

## ORDINANCE NO. 772

**AN ORDINANCE AUTHORIZING THE CONSUMPTION AND POSSESSION OF ALCOHOLIC LIQUOR AT A SPECIFIED LOCATION ON THE PUBLIC RIGHT-OF-WAY, AND THE CONSUMPTION, POSSESSION, AND SALE OF ALCOHOLIC LIQUOR IN THE CITY PARK, AND APPROVING THE CLOSURE OF PUBLIC PROPERTY FOR THE 2025 SOLOMON FESTIVAL STREET DANCE.**

**BE IT ORDAINED, BY THE GOVERNING BODY OF THE CITY OF SOLOMON, KANSAS:**

**Section 1.** Authorization is given to barricade the intersection of Poplar Street and Main Street, extending into a portion of the 200 Block of West Main Street (the “Intersection”), between the hours of 4:00 p.m. on July 19, 2025 and 2:00 a.m. on July 20, 2025 for the Solomon Festival Street Dance (the “Event”).

**Section 2.** The barricaded portion of the Intersection, as set forth above shall be temporarily closed between the hours of 4:00 p.m. on July 19, 2025 and 2:00 a.m. on July 20, 2025. Event attendees twenty-one (21) and older may possess and consume alcoholic beverages in the specified areas and during the times designated above. No person shall remove any alcoholic liquor from inside the boundaries of the event.

**Section 3.** Pursuant to K.S.A. 41-719(e), the City Park, title of which is vested in the City, is hereby exempted from the provisions of K.S.A. 41-719(d) on July 18 and July 19, 2025. Event attendees twenty-one (21) and older may possess and consume alcoholic beverages in the City Park on July 18 and July 19, 2025. Subject to obtaining the appropriate license and approval from the State of Kansas Division of Alcohol Beverage Control, Whiskey Wagon Mobile Bar d/b/a Tammy’s Country Catering is authorized to sell alcoholic liquor in the City Park during the Event, in accordance with all applicable state laws and municipal ordinances.

**Section 4.** City Code Section 3-104 pertaining to consumption on public property shall be waived in above-specified Intersection and the City Park, during the dates and times designated above for each such location.

**Section 5.** The Event is hereby approved by the Governing Body as required by K.S.A. 41-719(a)(3).

**Section 6.** This ordinance shall be in full force and effect from and after its adoption and publication once in the official city newspaper by the following summary:

### Ordinance No. 772 Summary

On June 11, 2025, the City Council passed Ordinance No. 772. The ordinance authorizes the consumption, and possession of alcoholic liquor at a specified location on the public right-of-way, generally described as the intersection of Main Street and Poplar Street, and approves the closure of said area for the Solomon Festival Street Dance. The ordinance also authorizes the consumption, possession, and sale of alcoholic liquor in the City Park on July 18 and July 19, 2025 for the event.
