# MINUTES CITY COUNCIL REGULAR MEETING SOLOMON KS 67480

September 11, 2023, at 6:00 pm

#### 1. CALL TO ORDER AND ROLL CALL AT 6:00 PM

Mayor McMillen called the meeting to order. A quorum was present.

#### 2. LAW ENFORCEMENT

• The August Activity Log was reviewed. There were 246 hours and 44 calls in Solomon for the month including: 17 traffic stops, 1 abandoned vehicle, 5 suspicious activity reports, 2 speak with officer, 1 theft, 1 civil matter, 1 court order violation, 3 noise, 1 park check, 1 juvenile complaint, 1 animal complaint, 6 open doors, 1 VIN inspection, 1 welfare check, 1 motorist assist, 1 arrest.

Sheriff Davis departed the meeting.

- b. Motion by Hemmy to adopt Ordinance No. 758 for the 2023 Standard Traffic Ordinance which reflects state legislative changes, seconded by Kirby, 3 Yeas, 0 Nays. Motion carried.
- c. Motion by Bush to adopt Ordinance No. 759 for the 2023 Uniform Public Offense Code which reflects state legislative changes, seconded by Hemmy, 3 Yeas, 0 Nays. Motion carried.

#### 5. STAFF REPORTS

- a. Senior Center No report
- b. Fire Department:
  - Fire Chief Paden recommended the bid from Watts Manufacturing LLC for the Type 4 Wildland Fire Apparatus which came it at \$273,500.00. We need to contact banks for a lease-purchase agreement. Motion by Bush to accept the Watts Manufacturing LLC bid of \$273,500.00, seconded by Kirby, 3 Yeas, 0 Nays. Motion carried.
  - Chief Paden would like to add a Knox Box for all commercial building permits.
  - Truck 611 is still waiting on the rear light bar to be completed. It is to ship soon.
  - The department responded to 16 calls in August:

<u>In the city</u>: 5 medical calls, 2 fire, 1 carbon dioxide detector, 2 school false alarms

In the county: 2 fires, 2 demo derby standbys

Out of district: 2 fires

- c. Maintenance Department:
  - Britt reported city wide cleanup will be October 16 − 20<sup>th</sup> in conjunction with Dickinson County. The landfill will take tires at No Charge. The city will not accept tires, residents can transfer on their own.
  - Well #11 is having issues and the motor and pump were replaced at a cost of \$7,000. Sargent Drilling and an electrician the city hired are currently working on a solution.
  - Britt received notification that the Old 40 railroad tracks west of town will be replaced around the end of September and will take approximately one week to repair. Detour signs will be placed where necessary.
  - Britt handed out two quotes for a new dump truck. The city purchased our 1987 dump truck in 1999 and it was 12 years old then. Finding a used one is impossible. Two quotes were presented:

MHC Kenworth Salina for \$159,685 for the cab and chassis

Rush Int'l for \$109,363 for the cab and Reed Company LLC for the equipment for \$50,250.

Motion by Kirby to order chassis from MHC Kenworth at \$159,685, seconded by Hemmy, 3 Yeas, 0 Nays. Motion carried.

Motion by McMillen to order the equipment from Reed Company at \$50,250, seconded by Kirby, 3 Yeas, 0 Nays. Motion carried.

- Resolution No. 2023-02 authorizes the city to apply to KDHE to finance water supply and distribution system improvements and the Notice of Intent to file an application with USDA Rural Development for financial assistance. Motion by Kirby to adopt Resolution No. 2023-02 as presented, seconded by Bush, 3 Yeas, 0 Nays. Motion carried.
